Dear Mr. Higginbottom:

1. This is for a renewal review of the Iowa Army Ammunition Plant's (IAAAP) 2018 Agricultural and Grazing Outlease Tract Management Plans (TMPs).
2. All of the 2018 TMP's have been reviewed by your office in the past (R&C#120529074, 070629008 and etc.). The tracts are outleased on a five year rotation. Changes to crop rotations and the addition of cover crops have been made to further reduce soil loss and improve site protection from soil loss.
3. We are enclosing the 2018 TMPs. The tract numbers are as follows 6, 14, 20, 31, 32, 34, 37, 43, 45, 46, 48 and 137. We are also enclosing a map (SK-842E) showing the locations of said tracts within the installation.
4. The following is a list of the tracts up for review and the sites that are within or partially within the actual farmed area of each tract.

- Tract 43 ✓ Site 13DM367 is a prehistoric and historic scatter listed as requiring Further Testing in the 1990 study by Augustana. Tested in 1997 by Tetra Tech, Inc. and determined as not eligible for listing in the NRHP.
- ✓ Site 13DM503 is a prehistoric camp complex listed as requiring Further Work in the 1990 study by Augustana. Tested in 1997 by Tetra Tech, Inc. and determined as not eligible for listing in the NRHP.
- Tract 137 ✓ No known site.


5. The tillage system in the lease contract limits the depth of tillage to less than 7 inches. The lease contract allows the lessee to request in writing to till deeper in fields within the tract that do not have known sites. Any approved requests will be ground truthed prior to any tilling. The amount of tillage done is also minimized through percentage residue requirements. These requirements also limit the number of tillage passes.

6. All fields have been deep plowed in the past.

✓ 7. The IAAAP submits a conditional determination of "No Historic Properties Adversely Affected".
