Environmental Remediation Services

Plexus provides comprehensive environmental remediation services through the entire CERCLA and RCRA processes to include Site Investigation (SI), Remedial Investigation/Feasibility Studies, Remedial Design, and Remedial Action; Operation and Maintenance; and Long-Term Management services, as well as their RCRA equivalent throughout the U.S. under FUDS, BRAC, IRP and MMRP. Contaminants of concern have included, but are not limited to: PFAS, petroleum products; chlorinated solvents and other volatile and semi-volatile organic compounds; explosives; metals; PCBs; pesticides and herbicides; and radionuclides.

Plexus specializes in Green and Sustainable Remediation (GSR) through innovation and optimization of the remediation approach to reduce a site's Life Cycle Cost (LCC). We have documented success in implementing GSR, reducing remediation carbon footprint, and achieving remediation goals with lower energy and water use. LCC reductions often require a more robust effort in the characterization phase in order to significantly reduce the remedial action phase, the

costliest phase of the remedial process, but this investment is worth it. Through our DoD performance-based contracts, we have a record of effectively, efficiently achieving Site Closeout (SC), Response Complete (RC), and Remedy in Place (RIP), thereby reducing our clients long term liabilities.

Plexus has worked with USAEC and USACE Louisville, Chicago, Baltimore, Buffalo, Albuquerque, and Tulsa Districts as a prime contractor, and for the Mobile, Sacramento, Los Angeles, and Omaha Districts as a key subcontractor. Plexus has performed, or is now performing, on 10 environmental remediation multiple award contracts as a prime contractor and executed over 100 Task Orders (TOs) under cost plus fixed fee, firm fixed price, and performance-based acquisitions worth over \$60 million. Plexus maintains in-house technical expertise that includes senior-level professionals who are certified by the American Board of Health Physics in the comprehensive practice of health physics with at least 25 years of experience in the radiation protection field. The firm's staff also includes Certified Health Physicists, a Certified Industrial Hygienist, and a Certified Safety Professional.

In use at the National Institutes of Health since 2004, the software is growing in use daily where it serves as their enterprise-wide Strategic plan Tracking And Reporting Tool (START) to meet the planning, data collection, and reporting needs of each of the institutes, centers, and offices while allowing the Office of the Director to coordinate activities and track progress.

With the advent of COVID-19, the Plexus team used the PPM platform to rapidly create a COVID-19 portal with easy-to-use features to help NIH manage the wealth of COVID-related data, including a COVID-19 repository of requests for information and their responses; a COVID-19 strategic plan for tracking projects and clinical trials; funding information by state, priority, and objective; KPIs across clinical trials, serology tests, rapid acceleration of diagnostics (RADx), and publications; a COVID-19 newsroom; and many other data elements presented in a unified interface. Plexus offers a full range of software development and support services for custom-designed solutions that precisely meet the needs of an organization.

The Plexus team used the PPM platform to create an information portal for Diversity, Equity, Inclusion, and Accessibility (DEIA) where authorized users from each of the NIH institutes, centers, and offices can respond to an annual survey on Management Directive 715, collaborate online with DEIA specialists and other interested stakeholders, and generate data analytics and reports from the survey data.

The Plexus team has also used the PPM platform to automate data calls for various types of information across the organization. Examples include creating an inventory of Artificial Intelligence applications that have been developed and implemented by each of the institutes, centers, and offices, and creating a collection of data to track collaborations within NIH, as well as collaborations with federal agencies, and other research organizations. After the data has been ingested, PPM provides a wealth of interactive data analytics for users to explore the data.




Figure 1- Plexus Headquarters and Project Locations

Health and Safety

The Plexus staff includes experienced health and safety professionals who provide Corporate and Project health and safety oversight and health and safety management. The Safety Program is led by a Certified Safety Professional and a Certified Industrial Hygienist. The Plexus staff have expertise in hazardous waste remediation health and safety; construction safety; chemical, biological, munitions and explosives of concern (MEC); and radiological health and safety. Health and safety-experienced staff prepare detailed site-specific Health and Safety Plans (HASPs) Accident Prevention Plans (APPs) and Site Safety and Health Plans (SSHPs) in accordance with OSHA 1910.120 and USACE EM 385-1-1, and ensure each on-site employee and subcontractor has the required OSHA training and medical surveillance in order to safely

perform site work. Radiation safety is led by senior Certified Health Physicists (CHP). Our exemplary safety record has earned us recognition from the National Safety Council (NSC) with a 2012-2019 Occupational Excellence Achievement Award and a 2014 corporate NSC Hazard Recognition – Gold Award through Crystal Award.

Quality – ISO and CMMI

Plexus's corporate culture is based upon rigorous quality control measures to support our client processes. Our Quality Control Program assures that products are not only of high quality, but also satisfy or exceed contractual requirements. Key features of our Quality Control Program are a process of internal standards and quality checks, senior level oversight, peer review, and client feedback.

Plexus's QA/QC Program is ISO 9001:2015 certified, ensuring that clients benefit from internal processes that are documented, learned, continually reviewed for improvement, and consistent with quality assurance best practices established by the International Standards Organization. Our ISO 9001:2015 certification remains valid until **December 13, 2022**.

Our software development organization has been CMMI Level 3 certified since 2005. The goal of our QA/QC Program is to encompass and implement the best practices of each of these certification authorities throughout all phases of the project development life cycle. Plexus was re-appraised for CMMI Level 3 in January 2024 and will remain certified until January 2027.

Plexus's Quality Manual establishes policies and procedures to ensure the quality of all activities conducted by the company. A Quality Control Plan is designed for each project to ensure that required standards are being achieved throughout all on-site and off-site operations, including any work done by subcontractors and materials provided by suppliers for the project.

Our Project Quality Control Plan helps with the early identification of deficiencies and/or non-conformities, promotes problem resolution, guides change management, and provides data, reports, and project deliverables that are accurate, reliable, and acceptable for their intended purpose. The Quality Control Plan identifies the organization and resources necessary to produce an end product that complies with contract requirements. The system was designed to satisfy the following key goals:

- Maintain auditable verification that our Quality Control Plan has been implemented and a quality product has been produced
